

Ski to Sea Race - Volunteer
RELEASE, INDEMNIFICATION, AND HOLD HARMLESS AGREEMENT

By my signature and acceptance below, I hereby enter into this binding Liability Release, Indemnification, and Hold Harmless Agreement (hereinafter referred to as the "Agreement") regarding my volunteer activity for the Ski to Sea event. For myself, my heirs, and executors, I hereby: (a) assume all risks, whether known or unknown, associated with or arising out of my volunteer activity for the Ski to Sea event, including but not limited to, falls, collisions, contact with objects, mud, deep water, slippery or uneven surfaces, spectators, motor vehicles, and participants, occurrences associated with weather, conditions of water and the natural and man-made terrain, and conditions of traffic, roads, trails, and obstacles; (b) waive any and all specific notice of the existence of these and any other such hazards or conditions; (c) assume full and complete responsibility for any injury, death, or accident arising out of or associated with my volunteer activity; and (d) **RELEASE** Ski to Sea and Whatcom Events, its directors, officers, employees, volunteers, or any agent or representative of them (collectively referred to as the "Event Organizer"), and **INDEMNIFY** and **HOLD HARMLESS** the Event Organizer from any and all liability, cause of action, claims, demands, costs or debts of any kind or nature, associated with or arising from or out of my volunteer activity for the Ski to Sea event, whether such claims are based on negligence or otherwise and whether brought by myself or by any third persons (collectively referred to as "Claims").

I understand that participation in the 2022 event includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. I knowingly and freely assume all such risks related to illness and infectious diseases, such as COVID-19. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.

I have read and understand all rules, course maps, volunteer instructions, obstacle descriptions, and disclosures stated on the Ski to Sea website. **I HAVE READ, UNDERSTOOD, ACCEPTED, AND AGREE TO BE LEGALLY BOUND BY THE CONDITIONS OF THE LIABILITY RELEASE, INDEMNIFICATION, AND HOLD HARMLESS AGREEMENT PRINTED ABOVE.**
